E-mails greater than 10MB will not be delivered and will not be considered. Therefore, quotes exceeding the size limit must be sent via multiple e-mails.

- 3. Each quote should contain the contractor's best terms from a price and technical standpoint. It is the contractor's responsibility to ensure that there are no discrepancies presented within the information contained in its quote. Potential quoters are hereby notified that in the event there are discrepancies within information in a quote will be rejected.

- (a) The Government will evaluate quotes by performing a comparative evaluation, comparing one quote to another, to identify from all quotations one that is suitable to the user and represents the best value to the Government considering price, equipment quoted, and other information provided within the quote demonstrating capability/capacity to deliver the items as required. This may result in award of a contract to other than lowest-priced if determined to be most advantageous to the fulfillment of the requirement.
- 1. **Total Evaluated Price (TEP)**: The Government will evaluate quoted prices by adding the total price for all options to the total price for the base year, to arrive at a total evaluated price (TEP). In determining whether a price is fair and reasonable, the government may use historical data, independent Government estimates in its price analysis, or any other technique permissible by FAR 12 and FAR 13.

The TEP will be calculated as follows:

- a) The sum of the extended prices (unit quantity multiplied by unit price) for CLIN's 0001-0003 for the base performance period and option periods one (1) through four (4); *and*
- b) To account for the maximum six-month extension possible under the clause at FAR 52.217-8, Option to Extend Services, the Government will take the quoted price of the final option period (CLIN 5001-5003), prorate it to a six-month value, and add that amount to the sum of all CLINS (base performance period and option periods one (1) through four (4)). The resulting amount will be the TEP. Evaluation of options shall not obligate the Government to exercise the option(s).
