STATEMENT OF WORK/BID SCHEDULE

Scope of Work for B9166 Floor

1) Objective:

Procure materials/services to apply an epoxy floor coating on a portion of the flooring in Building 9166 at NASA-Stennis Space Center. The area to be coated is 102ft by 30.5ft (approximately 3111 sq ft).

2) Details:

The contractor shall provide the coating materials, tools and anything else required for the proper application of the floor coatings.

The 3111 sq ft area will be free of any equipment or hardware. 120V, 15A electrical power outlets are nearby. A forklift and pallet jacks are available in the building.

The proposed floor coating for Building 9166 shall be based on the building activities which involved heavy loads and forklift traffic.

The contractor shall grind the floor to the coating manufacturer's recommendation for surface profiling.

There are some joints in the slab that may require cleaning/degreasing since they might be lower than the prepared surface.

The contractor shall provide shelf-life data on product prior to use.

The contractor shall apply an epoxy primer coat with a light gray pigment to the recommendations of the coating manufacturer.

The contractor shall apply a base coat of commercial grade 100% solids epoxy resin with a light gray pigment to the recommendations of the coating manufacturer.

The contractor shall apply a clear satin finish, UV stabilized, heavy duty urethane topcoat, that is high abrasion resistance, to the recommendations of the coating manufacturer.

The contractor shall remove all trash generated and unconsumed materials brought onto the site.

“Place of manufacture” means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

“Predecessor” means an entity that is replaced by a successor and includes any predecessors of the predecessor.

“Restricted business operations” means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174).
