Searching for Service Contract Act (SCA) Wage Determinations

1. To search for SCA WDs, including Collective Bargaining Agreements (CBA), choose the **Wage Determinations** domain from the search drop-down menu at the top of the page and click on **Search**. If you don't see the Search Menu, look for the magnifying glass icon on the top row and click to open Search.
2. From the **Wage Determination Type** filter on the left side of the page, select **Service Contract Act (SCA)** or **Collective Bargaining Agreements (CBA)**.
3. Enter the required information to narrow your search results. You can also sort by **Title** or **Date Modified**.
4. If any criteria, such as a specific location, is not present or the non-standard service does not strictly apply, you can submit an e98 Form from the information box.

Searching for Davis Bacon Act (DBA) Wage Determinations

1. To search for **DBA WDs**, choose the **Wage Determinations** domain from the search drop-down menu at the top of the page and click on **Search**. If you don't see the Search Menu, look for the magnifying glass icon on the top row and click to open Search.
2. From the **Wage Determination Type** filter on the left side of the page, select **Davis Bacon Act (DBA)** to view construction, alteration, and/or repair of public buildings or public works wage determinations.
3. Enter the required information to narrow your search results. You can also sort by **Title** or **Date Modified**.
4. If any criteria, such as a specific location, is not present or the non-standard service does not strictly apply, you can submit an e98 Form from the information box on the top right side of the Wage Determination Learning Center page.

Searching for Inactive (Archived) Wage Determinations

1. To search for **SCA** or **DBA WDs**, choose the **Wage Determinations** domain from the search drop-down menu at the top of the page and click **Search**. If you don't see the Search Menu, look for the magnifying glass icon on the top row and click to open Search.
2. To view **Inactive WDs**, uncheck the Active Status filter on the left-side navigation.
3. At the bottom of the Inactive WD you will find a timeline of revisions.

To Start or Modify a Collective Bargaining Agreement (CBA)

1. To Create a New CBA or Revise an Existing CBA you must be logged in with a government account.
2. Access **CBAs** from your **My Workspace**, scroll down to **Collective Bargaining Agreements**. Click one of three links:
 - **Create A New CBA** which takes you to a New CBA Form to fill
 - **Modify an Existing CBA** which opens a box to fill in with the number of the CBA, that takes you to the agreement
 - **Collective Bargaining Agreement Workspace** which is a dedicated CBA Search Tool with filters

Subscriptions are now “Following”

Subscriptions from the original WDOL site will not transfer over to beta.SAM.gov. The steps for subscribing on beta.SAM.gov are:

1. In order to **follow Wage Determinations** you must have a beta.sam.gov user account and be signed into your account.
2. Choose your **Wage Determination** from the **Search Results**.
3. Click **follow** in the top right corner of the Wage Determination. Click again to unfollow.
4. To manage what you are Following (subscriptions):
 - Go to your workspace
 - Select “My Profile”
 - Click on “Followings”
